Volunteers were requested for this purpose for Tuesday the 3rd June.

8. CITTASLOW The Clerk reminded members of the Open Meeting of the 13th May. A small delegation namely the Mayor, Tricia Carter, Kate Stewart and Cllr M. Davies-Evans will meet Mr G.Kidd before the meeting, for a guided tour of Lampeter. It was resolved to contribute £50 towards Mr Kidd's travelling/overnight expenses.
